

**Quaker Steak & Lube® “2018 Holiday Giveaway” Game  
Official Rules**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. ELIGIBILITY:** The Quaker Steak & Lube® “2018 Holiday Giveaway” Game (the “Game”) is open to legal residents of the 50 states of the United States and D.C., 18 years of age or older. Employees, directors and officers of QSL Operating LLC (the “Sponsor”), its affiliates, subsidiaries and advertising/promotion agencies and the immediate families (spouse, parent, child, sibling, grandparent, and spouse and “step” of each) and household members (those persons whether related or not who live in the same residence for at least three months during the twelve-month period preceding the start date of the Game) of each are not eligible to enter the Game or win a prize. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
